



Matching Gifts:

Maximize the Value of Your Donation

Corporate matching gifts can increase your gift to the Farmington Village Green & Library Association.

Thousands of companies match the charitable contributions of their employees. Usually the employee must be employed full time or be a retiree, but spouses' gifts may even be eligible. Gift matches may be dollar-for-dollar or more.

You can donate to the FVGLA and let its trustees decide the best use for your gift. Or, you may designate a specific entity in our care—such as the Stanley-Whitman House museum, the Farmington or Barney Libraries, or other FVGLA entity.

Contact your human resources or payroll department. If your company is eligible, request a Matching Gift Form, complete the donor section, and mail it and your donation to the FVGLA at:

We will validate your contribution with your employer, and they will send us the matched amount.

You will be recognized for the full amount of your own gift, plus the match. You also may take a charitable deduction for your donation as the FVGLA is a nonprofit association.
